#### **BILLS AND COMMUNICATIONS**

- UHS Trauma Teaching Day registration fee being paid for by the company for qualified EMS personnel is under consideration by the Board.
- We received a \$25 donation from Mrs. Rosemary Rinde for installation of smoke detectors.

#### **BOARD COMMUNICATIONS**

- Adrian agreed to be the contact person for both Station 1 and Station 2. Any issues
  involving the stations can be brought to Adrian, who will pass the information on to the
  Board. The electronic form can still be used, but you can speak to Adrian if you prefer.
- Adrian will be handling the vending machines and members can tell him if they have any preferences.
- Discussion regarding ordering and pickup of food for monthly meeting on a rotating basis.
- We will put a list of board member responsibilities for each position on the web site.
- Currently updating roster and it will go out on the web site when it is done, minus birthdates.

#### OFFICER REPORTS

CHIEF: None.

#### FIRST ASSISTANT CHIEF:

- ID cards are underway. Once the chief gets back we will set a date for when this needs to be completed.
- Smoke detector installation is going well. If anyone wants to help out, please let us know. One of the chiefs has to be there. We are at 180 detectors installed so far; the highest in the county. Let your friends and family know about the program. No cutoff date yet.
- On the East Maine call, crew integrity was very good. There was a lot of freelancing, but not by us. Stick with your crew.

#### **SECOND ASSISTANT CHIEF:**

- At the officer's meeting we talked about decreasing our monthly apparatus inspection schedule, but the East Maine fire showcased critical equipment failures for other companies. I am going to be taking a very close look at what we should be doing. (Discussion about how we usually check everything both monthly and weekly and how we will not be eliminating anything, but will be adjusting the schedule for monthly checks).
- We have been doing very well on our MVA and other miscellaneous calls.

FIRE POLICE CAPTAIN: None.

#### MAINTENANCE:

- Electronic reporting of maintenance issues is working great so keep it up. On Sunday the 27<sup>th</sup> Har-Rob is going to pick up a rig from Station 1. It should take one to two days unless it is something major or we have to wait for parts. I will send out e-mails when trucks leave. I have lists started for all rigs, so please keep reporting any issues to me. I think that even if we don't find anything, Har-Rob will find it because it is a very thorough examination. This will give us a good idea of how well our apparatus is holding up. It does not matter how minor, please let me know. (Ray says that at the parade on Saturday Engine 1 worked perfectly. Discussion about a leak in Engine 1).
- EMS needed big repairs, but it looks like it will be okay. If anything is not running correctly, like starting problems, please let us know. It should not go into high idle when it is put in park; please let us know if this happens. Rear door latch is still broken.
- Small apparatus will be staying local and will be serviced at Gault.

- Utility has two brand new batteries and extensive electrical tests were done on it.
- Don't hesitate to call me with any big problems.

#### AIR/CASCADE:

- Three Cascade bottles were hydroed this week. Thanks to Tom and Bill D. for taking care of that.
- Two small SCBA are going for hydro next week.
- I believe that everyone has been fit-tested who needed to be.
- All air packs are in service.
- New spray bottles of Culligan water, not tap water, are now located at both stations. When cleaning regulators do not use tap water anymore. Spray with disinfectant and let sit for 5 minutes to 10 minutes and then rinse with the spray bottle water. Can still use tap water for masks. If spray bottles are empty, fill them with Culligan water.

#### EMS:

- Jean has agreed to be the new EMS lieutenant pending proposed bylaw change vote.
   She has already run her first training.
- UHS training day will be on April 16<sup>th</sup> at the Binghamton Regency. I have asked the board to pay the fee for qualified EMS personnel. If you are interested, please let me know. It is a very good program and very worthwhile.
- Two mutual aid members from Maine will be running calls. All they need to do is get checked out driving the vehicles. Both are qualified on Maine's apparatus but need to be qualified on ours. They have a lot of experience.
- The third Thursday of every month will consist of scenario-based training for our new EMS people. It will be held at Station 2. Anybody is welcome.
- We are trying to get more med team members both inside and outside the company. If there is enough interest I may be able to run a CFR class this year. This is the logical place to have it. We can either run it one or two nights a week. This will also be for recertification.
- The new EMS link on the website has great information.

#### TRAINING:

- New spring list for state classes for Broome County has been published on their website. If you want to take any of them, sign up!
- CentreLearn classes are due at the end of March.
- A lot of incentive stuff is in and I will get it split up. I will send an e-mail when it's in and will probably leave it on your rack. Some is backordered.
- Bill D. and Tom made new pump lists and updated them. They are located on the rigs and also on the website. The lists received compliments at the East Maine fire. Thank you to Bill and Tom for a job well-done.
- We did some odd off-base training this month and everything went well.

#### SAFETY:

• Letters went out last month for physicals. A few more may be going out in the near future.

#### SOCIAL:

• We have a bylaw proposal to be voted on that the EMS captain may appoint an EMS lieutenant with the approval of the chief.

must be a member in good standing to take a leave of absence. We have two
members who took a leave and were not in good standing. The committee needs to
take look at this bylaw.

- Some new things are going to be put on the web site and the committee will be doing some cleaning up. The format will generally stay the same. - The board had a brief discussion today about going through the roster and focusing on the people who have not been coming around very much. We need to reach out to them and find out what is going on. We need to keep in closer contact with the people who are drifting away, but this is a work in progress. If you have any ideas on how this can be accomplished, please let us know.
