the insurance company and then we will be able to address the problems with the gutters, roof and mold.

  pager or radio needs something, change contact with Lt. Miga (pagers) or myself.
- There is a rumor that the pigtail adapters that were made for use with Maine's
  electrical equipment do not work (or plug in). We did try plugging into Maine's
  equipment at a call this week and we were successful. Make sure you are using
  the correct side of the pigtail to plug into their equipment. Any further issues let
  me know.
- Reminder: everything on the monthly checks should be completed unless told not to by an officer. There is concern that some checks may be getting skipped.
- Some members were asking if we are going to add Endwell's new Quint to our run cards. The Chiefs discussed this, but nothing has been decided. We will let you know when something changes.

#### **MAINTENANCE:**

- After the Utility's fuel gelled last week at the Fire Academy, we have decided to start using a fuel additive. This is to help prevent further issues in the future. Every truck with a Diesel engine has been treated. We will be treating fuel after every other refill to prevent over-treating. During the winter months, one bottle of additive treats 30 gallons and treats 60 gallons during warmer weather. Please don't add a bottle unless you were told to previously. The Chief and I have spoken to a few drivers to limit any confusion. Any questions, please ask the Chief or myself.
- The "slide out" step on the rear of the Rescue is OOS, please do not use. We are
  in the process of replacing it with a "slide out-drop down" style. We are just
  waiting on dimensions and confirmation that this will work for us.
- In the last two months, the Chief and I have replaced all Thermal Imager batteries with new ones. Any issues, let us know.

## AIR/CASCADE:

- Everything is in service and flow testing is done, with no major issues.
- Fit testing was done. If you could not get your fit test, Maine is supposed to be holding a fit test on a Tuesday night in February (date currently unknown).

## **NEW BUSINESS**

C. Hoyt said that the officers met before the first budget meeting to discuss rig replacements. It was decided that the brush truck is due to be replaced. The current chief's vehicle will be converted to an EMS vehicle and a new Tahoe will be purchased for chiefs. The 2014 bid took so long from the State that Chevy has ceased production of the vehicle we wanted. New pricing will be out in about a month. It will probably be early summer before we get State approval, with delivery in the winter, which is not as soon as we hoped. A. Holton will work with R. Serowik to get pricing on cabinets to convert the Tahoe to the EMS vehicle. The old Tahoe cabinet will go into the new one.

C. Hoyt said that nothing on the State bid will work for the brush truck. We will purchase a 1-ton vehicle and all we need can go on it. We will use our skid with a new pump. It will be a flatbed truck, not a pickup. It will have a hose reel with forestry hose. The brush truck committee has looked at other options and the prices were higher for specialty trucks. Chevy came in at about \$8000 lower than Ford. We are asking for up to \$65,000 to purchase a new truck by membership vote. B. Dieffenbacher said that due to our outlook plan, we have saved up money for this and the money is already allocated. We can afford it. C. Hoyt said that he will check with dealers on whether we might be able to package two vehicles together, instead of waiting until winter for the EMS/Tahoe exchange.

Membership vote regarding authorizing \$65,000 to be used to purchase a new brush truck (thank you brush truck committee, for all of your hard work).
