- Replace all air bags with mat jack, get prices on hose replacement
- Capt Mann, Driver training on rescue, Needs hot run also started on PT
- Scott Drake started to driver train on Squad

- Stephan was good with pumping and driving on Brush
- ➤ Auto alarms remain officer discretion if they want to cancel with proper code or no fire problem notification from homeowner
- Worked on equipment outlook see worksheet below

Equipment outlook budget sheet- REVIEW

Air bags –buy this year aprox \$12,000 which leaves \$8,000 to be allocated. Bags are recommended to be replaced every 10 years, so saving \$1,500 per year should be good until replacement again in 2027. Re-evalute prices in 2022

Turn out gear- buy needed gear this year from outlook, set aside enough for 2 sets (\$4,800) per year starting 2018 budget. Evaluate pricing and needs yearly.(large helmet order in 2018 due to end of service)

Genesis- save 2,000 annually for replacement. Replacement of current to be determined with funds saved in outlook

Thermal Imagers- currently have 7 in service. Save 2,000 per year for replacement. Possible purchase of 2 new from outlook savings this year. Evaluate savings in 2022 adjust as needed

SCBA- to be determined due to grant, appears to be on schedule if grant is not awarded. Evaluate 15 year outlook and needed annual savings once grant is received or SCBA's are purchased

RIG OUTLOOK/REPLACEMENT IDEAS

Replace Chief car with Pickup in 2018 –Aprox \$55,000

Current chief car would update EMS- EMS could move to station 1 for utility use/ auxiliary

Replace chief car (Pickup bought in 2018) again in 2023 aprox \$65,000 - pickup would then move to replace 20 year old current utility.- Sell 2003 pickup at this time.

1987 Rescue- determine what is needed. Either re chassis ,replace,or de commission , If replacement(possibly smaller) or re chassis would be 2022 at soonest unless funds available earlier

Tanker evaluate in 2022 , with hopes in service until 2030 replace at aprox \$534,000

Brush- in service until 2033, replace at aprox \$125,000

Current squad – evaluate condition in 2021, possibly replace 2024 at aprox \$861,000 \$999,000 in 2029
